3. SAFETY AROUND SCHOOLS

Wollongong MP Paul Scully has provided Council with the results of the Wollongong NSW School Safety Survey. The survey provides key facts on transport to school, key concerns and how children currently travel to school.

The report has listed concerns raised from the community regarding most schools in the Wollongong electorate. The report makes suggestions for improvements to issues such as cycling, parking and public transport.

At this stage Council has received this feedback and considering a strategy to improve infrastructure around all its schools in the LGA.

Requested Group Feedback

• Members may provide some comment on the survey; However, Council is currently working towards incorporating this documents into a strategy to review the existing infrastructure at all schools and prioritise future projects.

4. ACCESS AND MOVEMENT FOR PEOPLE

The Wollongong City Centre Access and Movement for People project aims to develop a future transport network that will support a pedestrian friendly, vibrant and liveable city centre. Council engaged the community from 25 February 2020 to 27 April 2020 for the first of three project community engagement phases. A number of online engagement tools were used to gauge the community's experiences travelling in and around Wollongong City Centre and their needs travelling through or staying in city streets. An interactive map allowed identification of specific locations with comments.

A presentation will be made to the group on information received through the online tools as well as other engagement exercises.

Requested Group Feedback

• A short survey was provided to receive feedback on respondents' experiences and any issues. Finally, an ideas page was made available to accept suggestions for change.



5. HELENSBURGH TOWN CENTRE UPDATE

Council is planning big changes for the Helensburgh Town Centre. We currently have two planning documents out for consultation:

6. CYCLING STRATEGY UPDATE

Following workshopping with the Walking Cycling and Mobility Reference Group, along with other key stakeholders, the Draft Cycling Strategy 2030 was presented to Councillors at their briefing on Monday 11 May 2020.

Following the briefing, changes and improvements have been made to the document on direction of Council's Executive team. These changes address research, innovation, tourism and events in line with expectations surrounding Council's vision to become a UCI bike city and support cycling. Further changes were needed to address COVID-19 and its impact on our community, and our actions in respect to improving cycling in a post-COVID world.

The revised draft will be reported to Council's ordinary meeting on Monday 29 June 2020, alongside the updated Infrastructure and Operational delivery programs. We will then proceed to an extended public exhibition period.

Requested Group Feedback

The Reference Group will be provided a copy of the revised draft in the near future, with comments to be considered as part of the overall community exhibition.
