3. BEACH ACCESS RAMP – AUSTINMER BEACH

We invite your feedback on plans for a beach access ramp to be installed at Austinmer beach. The proposed ramp has been designed to withstand the harsh coastal environment and changing sands and tides, ensuring accessibility to the beach is maintained into the future. Improved access benefits the whole community including those using wheelchairs or prams, people with limited mobility and carers. At this stage construction is planned for the off-peak period of winter 2021.
