19/06/2012	1	Car park adjacent to Memorial Park, LHD, Thirroul	Can Council please confirm who owns this area of land which is used as a commuter car park? If this area is Council' s responsibility can the area be line marked to make more efficient parking?	Infrastructure and Works	This car park is located on the road reserve controlled by NSW Roads and Maritime Services, a large portion of RailCorp land and a small amount of private land. Accordingly Council has no plans to provide any improvements to the car park.
19/06/2012	2	Thirroul train station car park, Station Street, Thirroul	Can the car park to the east of the station, adjacent to Thomas Gibson Park, have arrows indicating entrance and exit?	Infrastructure	The car park is located on State Government land and Council has no plans for any line marking in this area. The car park is small and accommodates less than 30 cars and additional line marking by RailCorp is probably unnecessary.
19/06/2012	3	Traffic bubble, south of roundabout, corner of LHD & Hewitt's Ave, Thirroul	Can Council clarify what the purpose of the concrete bubble is? NF members report that it impedes the movement of vehicles.	Infrastructure	<p>The traffic bubble referred to is probably the kerbside island on the south bound carriageway, to the south of the roundabout. The kerbside island is in place to ensure vehicles slow down to negotiate the exit lane from the roundabout. It is working effectively if traffic flow is impeded.</p> <p>In the event the NF is concerned about a different feature, please clarify and refer back to the Traffic Unit.</p>
19/06/2012	4	Hewitt's Creek Floodplain Risk Management Plan	NF2 members request an update on this management plan?	Organisational Strategy Improvement	The first meeting of the committee will meet in August 2012. Committee members will oversee the whole process which is expected to last for 2 years.
