2. Wollongong City Council:

Naming of West Dapto Suburbs: Process progressing

The report is seeking Councillor support to progress the proposed new boundary and names for Suburbs 'A' and 'B', to the Geographical Names Board. The proposed suburb names are 'Stream Hill' and 'Kembla Grange'

3. Romeo Cecchele:

The issues regarding roads were discussed:

- (i) Upgrades of first 500 metres of West Dapto Road. *Response:* WCC has plans for the upgrade in due course.
- (ii) Fairwater Drive between Lucas and Highcroft Drives in need of repairs. Response: Residents are encouraged to report concerns over potholes direct WCC.
- (iii) Water flow: While some work has been undertaken there remains a need to open up Dapto East Brook (trees cleared from the middle of the channel).

 Concern raised that silt pumped to clear pipes appears to have been pumped directly into the adjacent stormwater main.
- **3. Stephen McGartland -** Updates regarding issues raised at October NF8 meeting.

McDonalds: The Commissioner rather than dismiss the DA in its entirety has invited the parties to consider his recommendations and see if they can provide a solution.

At this time WCC intend to still oppose it. Next hearing is Dec 17th.

Darkes and Sheaffes Rd intersections:

Corey Stoneham noted that he had not yet received the email regarding this issue. Ian Fitzgibbon will forward the email to Corey.

4. Lake Illawarra Jetties

Any progress on the jetties project? Those present were not aware of the current status of this project. There is no apparent commencement of Crown Land's major repairs to 5 jetties, including Old Merinda Wharf, Tuggerah Bay Jetty, Koonawarra bay Jetty and Purry Burry Bay Jetty.

5. Council Elections.

It was noted that Council Elections will be held on 4th November.

6. William Beach Park Upgrade Progress:

Steady progress is underway on William Beach Park.

7. Ron Cooper:

Ron raised concern that original Wongawilli homes were not included in planning for new estate plans for connection into sewer. Ron noted that while residents have been advised that it is now permissible for village residents to connect into the sewer this is prohibitively expensive

PROPOSED CONCRETE FOOTPATH WORKS AT CRAIG CRESCENT, DAPTO

As part of our commitment to maintaining and improving our City's assets, we have prepared designs for a new concrete footpath at Craig Crescent between Cirrus Street and Rink Road.

We're planning new concrete footpath and kerb ramp works. As part of these works three (3) existing trees have been marked for removal as they are unsuitable due to the presence of overhead power lines. Ten (10) new trees of a smaller species have been proposed. Plan No. 7102_SK01_1 is attached which detail the work.

We're expecting to start the project 2021/2022.

During construction you will see a construction work crew, their vehicles and equipment in the area. The work crew will aim to minimise disruption, however there may be some traffic control requirements at times. We'll contact you before we start to let you know what dates we'll be onsite.

3. Follow Up from Previous Meeting - Stephen McGartland

Re updates: purely my opinion and interpretation only. I very well could be wrong:

(i). McDonalds. Some residents met with WCC Legal.

Complicated by fact Commissioner rather than dismiss the DA in its entirety has in his discretion invited the parties to consider his recommendations and see if they can provide a solution.

At this time WCC intend to still oppose it.

Next hearing I think is Dec17th.

My personal opinion is that the judgement provides wriggle room for McDonalds, gave low weight to WCC intentions for the site and provided token reference to the public submissions when the the intent and public interest is clearly captured in the submissions.

Example: In WCC DCP it clearly states to develop centres with less reliance on fast food etc. One of the public submissions was a Health professional who articulated all the issues very clearly. The Commissioner basically said that because WCC didn't call expert witnesses on the Fast Food issue it wasn't really a contended matter.

(ii) Darkes and Sheaffes Rd intersections:

Still to hear from WCC on matter.

Can we please have an update from our councillors on the following important issues for Horsley residents:

- (i)When will major upgrade work start on the very dangerous first 500 meters of West Dapto Road?
- (ii) When will replacement asphalt work be done on the 100 potholes on Fairwater Drive between Lucas and Highcroft Drives?
- (iii) Why after four weeks of work on the vacant corner block at the corner of Bong Bong/Hamilton Roads by three contractors was the Dapto East Brook not properly opened up (trees cleared from the middle of the channel) and why was all the silt pumped straight into the stormwater main adjacent?
