2 FLOOD MANAGEMENT UPDATE

2.1 Fairy and Cabbage Tree Creeks Flood Study 2020

The Fairy and Cabbage Tree Creeks Flood Study 2020 was placed on public exhibition from 6 April to 11 May 2020 and adopted by Council on 29 June 2020.

The committee noted the provided information and update.

2.2 Fairy and Cabbage Tree Creeks Floodplain Risk Management Study and Plan Review

The consultant from Advisian provided a brief presentation to the committee. The consultant is currently updating the Flood Study in accordance with updated National Guidelines.

Once preferred options have been identified, consultation with the committee and wider community will be undertaken.

2.3 SMART Waterways Project

Ingrid Mcalpin, WCC Chief Information Officer IM&T, provided information and background regarding the SMART Waterways Project. Discussions are currently underway within Council to move forward with the project. Cr Dorahy expressed his support.

2.4 Allans Creek Floodplain Risk Management Study and Plan Review

The consultant from Rhelm provided a presentation to the committee and advised the Flood Study Review as part of the Flood Risk Management Study and Plan.



The draft information presented was part of the sensitivity analysis for ARR2019 updates. Design modelling is still to be carried out to determine model flood levels, including consideration of climate change.

Several items were raised regarding outcomes of the Plan and implementation of mitigation measures. Once preferred options have been identified, consultation with the committee and wider community will be undertaken.

2.5 Floodplain Management Grant Applications

The committee noted the following successful grants:

- Wollongong City Floodplain Risk Management Study and Plan
- McMahon Street Basin Detailed Design

These will be progressed and updates will be provided at future committee meetings.

The outcome of the McMahon Street Basin project will result in assisting downstream properties.

2.6 Recent Floodplain Risk Management Plan Implementation

The committee noted the current works underway, which will proceed with further design.

Preferred options within the Study areas will be identified as part of the Floodplain Risk Management Plans and will be presented to the next Central Area Committee meeting, along with community engagement.
