#### b) Alan Davis (Manager City Works, Acting)

Alan outlined progress in works:

- Pedestrian-cycle path around Wongawilli Rd.- Shone Avenue intersection;
- Darkes Road Bridge Closure: engineering & geo-technical reports show need for extensive works to repair the bridge. Reopening of road is not imminent.

#### <u>c) Tom McColl</u>

Tom responded to questions about the value of maintaining engagement through direct communication and affirmed council's support for Neighbourhood Forum meetings to run in a hybrid (in-person & zoom) format.

#### 9. GENERAL BUSINESS

#### (Q: questions/issues raised. R: response at meeting)

#### **Issues Raised:**

- b) Romeo Cecchele: The four issues that I would like input and update from WCC staff and our councillors are:
  - 1. **Q:** West Dapto Road-when will the very dangerous first 600 meters of West Dapto Road be raised with culverts every 50 meters?
    - **R:** It was noted that this question has been addressed previously and is to be considered in view of planning for roads throughout the West Dapto Area
  - Q: Darkes Road(now closed)-when will the bridge over Mullet Creek be raised by one meter as I requested in 2013 with ramping also provided and road upgraded?
    Ami Beck had also raised Darkes Road bridge as an issue of concern.
    R: Alan Davis noted that Geo Tech & Civil Engineering studies of Darkes Road Bridge damage indi cate need for substantial to be planned and undertaken time for repair TBA.
  - Q: Bong Bong Road-when will the dangerous intersection of Hamilton Street be made safe by dredging out the northern side of East Dapto Brook to allow water to flow to Mullet Creek?
    R: This issue has been raised and addressed at previous NF8 meeting.
  - 4. **Q:** Cleveland Road-when will the dangerous upgrade done by WCC in 2015 be raised by half a meter with culverts every 50 meters to allow better access in heavy rainfall events as was requested in 2013?

R: This issue has been raised and addressed at previous NF8 meeting.

# Council Officers noted these question for follow up consideration.

#### C) Dennis Couley: Brooks Reach Park

Q: What is the best way to have facilities to promote engaging play at Brooks Reach Park, similar

what is installed at William Beach Park and Bankbook Park?

**R:** Advise the person inquiring to contact Council re their inquiry.

#### D) Stephen McGartland - regarding Development Application Conditions

Q: What is the procedure for following up on conditions for D.A.'s to ensure compliance?

**R:** Discussion re various developments where conditions appear not to have been met.

Cr. Ann Martin acknowledged the difficulty in following up where private certifiers have been

engaged to progress the development.

## **Standing Items:**

West Dapto Roads: The standing items were addressed in following up enquiries from Romeo Cecchele.

It has been noted that further to previous concerns there have been significant impacts from ongoing rain events.

Currently several roads are impassable resulting in limited access for many residents and emergency service vehicles.

It was noted that the combined impact of current roadworks, potholed and water damaged roads along with the Darkes Road bridge closure has severely impacted the access to West Dapto causing safety risk concerns.
