A) Wongawilli DA for MacDonalDs, 24 Hour Petrol Station & Childcare Centre

Steve McGartland outlined community concerns that this proposal is not appropriate fit for the Neighbourhood Facilities indicated in the masterplan.

Steve requested that WCC Councillors join the community in voicing their objection to this proposal.

Cr. Vicky King noted council officers recognise disparity between West Dapto Masterplan and MacdonalDs DA and Vicky supports residents in their objections.

N.B. Following discussion it was resolved that NF8 send letter objecting to the Wongawilli MacdonalDs Development Proposal to WCC

B) Highway Medical Centre Paid Parking Proposal
