- 4 DECLARATIONS OF INTEREST:

Carol Herben declared a non-significant, non-pecuniary interest in relation to Waterfall General (Garrawarra) Cemetery (Item 7 of Agenda).

Annette Williams declared a non-pecuniary interest in relation to Berkeley Pioneer Cemetery Restoration Group (Item 10 of Agenda).

7 WATERFALL GENERAL (GARRAWARRA) CEMETERY DRAFT PLANNING PROPOSAL Joel introduced Emma Struys, Strategic Project Officer with Land Use Planning. Emma provided update to those present on the draft Planning Proposal in accordance with information provided in Business Paper.

Joel advised in relation to the progression of other outcomes of the project that hand over to Council's Property Division, who are taking over this project, has commenced

6 HILL 60 MASTER PLAN






