Wollongong City Council Infrastructure, Strategy and Planning Division Transport and Stormwater

The City of Wollongong Traffic Committee is not a Committee of Wollongong City Council however a Technical Committee of the Roads & Maritime Services (RMS). The Committee operates under the authority conferred to Council by the RMS under the Transport Administration Act 1988. Council has resolved to manage the Traffic Committee under a Charter which sets out the membership, timelines for the preparation of the Agenda and the distribution of Minutes, in accordance with the RMS document 'A guide to the delegation to councils for the regulation of traffic' (including the operation of Traffic Committees.)

Council has been delegated certain powers, from the RMS, with regard to traffic matters upon its local roads. A condition of this delegation is that Council must take into account the Traffic Committee recommendations.

There are four permanent members of the Traffic Committee, each of whom has a single vote only.

- The members are representatives of the NSW Police Force, the Roads & Maritime Services, the Local State Member of Parliament (for the location of the issue to be voted upon), and a representative of Wollongong City Council.
- If the RMS or NSW Police Force disagrees with any Traffic Committee recommendation, or Council's resolution on any Traffic Committee recommendation, that member may lodge an appeal with the Regional Traffic Committee for determination. The appeal must be lodged in writing within 14 days of Council's resolution. Any action relative to any issue under appeal must cease until the matter is determined. The Regional Traffic Committee is chaired by an independent chairperson and submissions and representations are welcomed from all interested parties.

Council can only recommend that:

- 1 The Traffic Committee recommendation be adopted.
- 2 The Traffic Committee recommendation not be adopted.
- 3 The Traffic Committee reconsider this issue.

BUSINESS ARISING

GENERAL BUSINESS

1 HELENSBURGH – WARD 1

Cemetery Road - Relocation of the No Stopping Signs.

Background:

Council has been requested by the Hope Church in Helensburgh to move the No Stopping Signs closer to 23 Cemetery Road where the road is wide enough to allow a car to pass the parked car and remain on the correct side of the road. The Church have pointed out that they have received complaints that traffic travelling east on Cemetery Road have to stop and wait for traffic travelling west on Cemetery Road to clear before passing on the incorrect side of the road.

Consultation:

Consultation with the Hope Church was carried out for this Agenda item.

PROPOSAL SUPPORTED UNANIMOUSLY

Relocate the existing western most No Stopping sign on the northern side of Cemetery Road 20 metres to the east.

2 NORTH WOLLONGONG – WARD 2

Ajax Avenue – Review No Stopping Restrictions.

Background:

After inspection of the intersection at Ajax Avenue, North Wollongong It is proposed that No Stopping restrictions be installed past the lane directional pavement arrows on the southern side on the approach to the Flinders Street signals. The roadway around the curve in Ajax Avenue which links to Montague Street also needs restrictions as on the weekends numbers of vehicles park on the outside of the curve.

Consultation:

No consultation was required for this Agenda item.

PROPOSAL SUPPORTED UNANIMOUSLY

Install No Stopping restrictions

- a) Between the driveway of 5 Ajax Avenue and the Flinders Street (Princes Highway) intersection.
- b) From the driveway to 1 Ajax Avenue to the power pole on the edge of the bridge at Montague Street.
- c) From the kerb blister outside 18 Ajax Avenue to the power pole at the northern side of the bridge at Montague Street.

3 NORTH WOLLONGONG- WARD 2

Montague Street – Review delineation at the junction with Bourke Street.

Background:

There have been reports of a recent vehicle crash at the vicinity of the junction of Bourke and Montague Streets. Although driver behaviour is likely to be a significant contributor a review of the delineation maybe helpful in reducing the risk of further crashes. On both approaches there are curve warning signs with an advisory speed and two hazards markers are located either side of the northern extension of Montague Street. Replacing the curve warning signs with high visibility fluorescent signs and installing edge lines is an appropriate improvement, together with the installation of edge-lines on both approaches.

Consultation:

Consultation has been carried out with adjoining residents for this agenda item.

PROPOSAL SUPPORTED UNANIMOUSLY

Install edge lines on Montague Street and Bourke Streets, North Wollongong on the approach to the T Junction between the Cabbage Tree Creek Bridge and Montague Street and extend along Bourke and Cowper Streets to Elliotts Road.

4 WOLLONGONG - WARD 2

Crown Street – Proposed No Parking Zone.

Background:

Council has received a request for a No Parking zone (Pick Up and Drop Off) on Crown Street between Corrimal Street and Kembla Street. This request was made by representatives from a Taxi Company and a Passenger Collection Service. There is a lack of drop off and pick up points in this busy commercial and retail area, which includes a medical centre.

Council's proposal is to install a No Parking zone in part of the existing No Stopping zone onto the westbound departure side of Crown Street (outside 51 Crown Street) where it intersects with Corrimal Street.

Consultation:

No consultation was required for this Agenda item.

PROPOSAL SUPPORTED UNANIMOUSLY

Replace part of the No Stopping zone with No Parking on the westbound departure side of Market Street at the intersection of Corrimal Street to provide two spaces.

REGULATION OF TRAFFIC

5 THIRROUL – WARD 1

McCauley Street - Changed from 15 August to 20 September 2018.

Background:

A builder has applied for a road closure on Wednesday, 20 September 2018 between 3 am and 7 pm in McCauley Street Thirroul, at house No. 32 (opposite Harbord Street). The attached TMP requires a detour around the site via Bath or Ocean Street, Cliff Parade, Spray Street, Ann Street, Station Street and Raymond Road. It will be desirable for advance warning to be given by way of two VMS boards on McCauley Street 7 days before the closure. The work will involve a large crane under a special vehicle permit, and which will need to be assembled on site.

The building units will be delivered by over width/over length vehicles and for these reasons it is necessary to remove parking from both sides of McCauley Street at the intersection with Lawrence Hargrave Drive. Similarly parking will need to be removed at the corners of McCauley and Ocean Streets, Ocean Street and Cliff Parade.

The trucks and crane involved require the width of McCauley Street to be occupied for the period of the closure and residents will be advised that only limited vehicle access will be available during the closure. This item is a resubmission due to the change of date previously approved for 15 August.

Consultation:

Consultation with affected residents is a requirement for this Agenda item.

PROPOSAL SUPPORTED UNANIMOUSLY

The proposed road closure be approved subject to the submitted Traffic Management Plan (Attachment 2) and Council's Standard Conditions for Road Closures (Attachment 1), the use of two Variable Message boards in McCauley Street 7 days in advance of the closure to advise of the work, and that consultations be held with those business operators and home owners affected by the closure and the loss of street parking.

DESIGN ITEMS

6 OTFORD ROAD- WARD 1

Station Road - Road Signs and Line Marking.

Background:

As part of the upgrade/road widening on Station Road, Otford, Council is proposing new line marking with new No Stopping signs and No Parking signs. When completed there will be a turning area for parents from the Otford Road PS which will eliminate any need to reverse.

Consultation:

Consultation is a requirement of the design process. ...

7 WOONONA- WARD 1

Haddon Lane Carpark - Disabled Parking.

Background:

Haddon Lane carpark is due to be resurfaced and upgraded and the proposed design includes two additional disabled parking spaces.

Victoria Street and Princes Highway - New Traffic Signals.

12 KANAHOOKA – WARD 3

Kanahooka Road and Lakeside Drive Kanahooka – Car Park Parking Restrictions.

Background:

Council has received requests form NSW Police and residents in the area around Kanahooka Point for curfew parking restrictions in the car parks to restrict instances of anti-social behaviour by drivers. As a trial for the 2018/19 summer period it is proposed to install No Parking in the car parks off Kanahooka Road and Lakeside Drive to be timed 10 pm to 4 am. It is expected that fishing activities will not be unduly affected with the end time for the restrictions being 4 am.

Consultation:

Consultation has been carried out with NSW Police and residents in the area.

Install No Parking restrictions in the car parks off Kanahooka Road and Lakeside Drive to be timed 10 pm to 4 am as a trial for the summer 2018/19

13 KEMBLA GRANGE - WARD 3

Kembla Grange – Reddalls Road – No Stopping Restrictions at the entrance to Whytes Gully, Waste Disposal Depot.

Background:

Council has recently obtained approval for a new stage of operations at Whytes Gully and one of the conditions from the Environment Protection Authority was the installation of No Stopping Restrictions in the vicinity of the landfill entrance to prevent vehicles queuing prior to opening times. No Stopping Restrictions are needed to be installed 60 metres either side of the entrance gates in Reddalls Road on both sides of the roadway.

Consultation:

Consultation is not required.

14 **DAPTO – WARD 3**

Council has prepared plans for a new roundabout at the intersection of Mulda and Byamee Streets in order to improve traffic safety for turning vehicles and to function as a traffic calming device on Byamee Street.

Attachment 1 – Standard Conditions for Road Closures

Standard Conditions for Road Closures

For Special Events and Work Related activities Within Council Road Reserves.

Following approval by Wollongong City Council, road closures are subject to the additional Council conditions:

- The Applicant must complete the Council form 'Application to Open and Occupy or Underbore a Roadway or Footpath' (Refer to Checklist below – relates to Section 138 of the Roads Act.)
- NSW Police Approval: The Applicant must obtain written approval from NSW Police, where required under the Roads Act.
- If the Road Closure is within 100m of any traffic control signals or on a 'State Classified Road' the Applicant must obtain a Road Occupancy Licence (ROL) from NSW Roads & Maritime Services (RMS).
- The Applicant must advise all affected residents and business owners within the closure area
 of the date/s and times for the closure, at least 7 days prior to the intended date of works.
- The Applicant must advise Emergency Services: Ambulance, Fire Brigade and Police, Taxi and Bus Companies of the closure dates and times in writing, 7 days prior to the intended date of works. The Applicant must endeavour to minimise the impact on bus services during the closure.
- Traffic Management Plan: The closure must be set up in accordance with the approved Traffic Management Plan (TMP) prepared by an appropriately qualified traffic controller; a copy of whose qualifications must be included with the submitted TMP.
- Traffic Management Plan Setup: The Traffic Management Plan must be set up by appropriately qualified traffic control persons or the NSW Police.
- Access to properties affected by the road closure must be maintained where possible.
 Where direct access cannot be achieved, an alternative arrangement must be agreed to by both the applicant and the affected person/s.
- Public Notice Advertisement: The Applicant must advertise the road closure in the Public Notices section of the local paper, detailing closure date/s and times at least 7 days prior to the closure.
- 10. Public Liability Policy: The Applicant must provide Council with a copy of their current insurance policy to a value of no less than \$20 million dollars to cover Wollongong City Council from any claims arising from the closure.






Attachment 2

Station Road, Otford – Signage and Line Marking






Attachment 4 Haddon Lane Carpark, Woonona – Disabled Parking







Redgum Ridge Estate Road, Figtree – Signs and Line Marking










Attachment 7
Victoria Street and Princes Highway Unanderra— New Traffic Signals





Victoria Street and Princes Highway Unanderra – New Traffic Signals




