DA-2021/987, Lot 34 and 35 DP 241764, Lot 201 DP 788229, Lot 79 DP 32179, Mount Kembla Park, Stones Road, Mount Kembla (as described in detail in schedule 1).

### PUBLIC SUBMISSIONS

The Panel was addressed by two (2) submitters.

The Panel heard from the applicant.

### PANEL CONSIDERATION AND DECISION

The Panel considered the matters listed at item 7, and the material presented at the meeting and the matters observed at site inspections listed at item 8 in Schedule 1.

The Panel determined to approve the development application as described in Schedule 1 pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous

### **REASONS FOR THE DECISION**

The reasons for the decision of the Panel were:

- The Panel agrees with the Council Officer's report subject to an amended condition 13 to change the restricted hours of operation to commence at 7am (Monday to Saturday) due to proximity of residential receptors.
- The Panel is satisfied that Council has formal effective procedures for the licencing and management of Commercial Fitness Activities including complaints resolutions.
- Subject to the inclusion of an additional restricted consent condition enabling a period of 24 months from the date of endorsement due to the potential impacts of the proposed Illawarra Escarpment Mountain Bike Concept Plan Mount Kembla.

### CONDITIONS

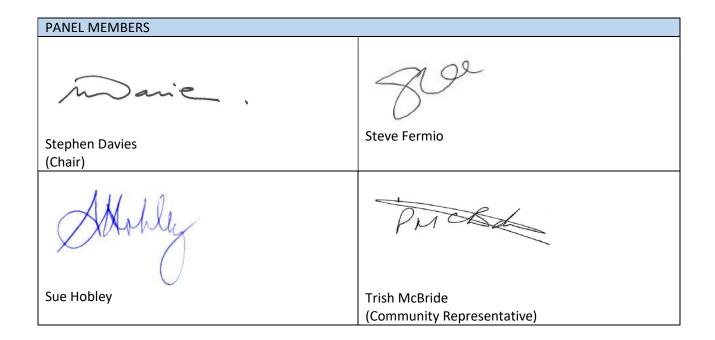
The development application was approved subject to the conditions in the Council Assessment Report with the following amendment:

### • 13 Restricted Hours of Operation

The hours of operation for the development shall be restricted to 7.00am to 8.00pm Monday to Saturday and 7.00am to 10.00am Sundays. Any alteration to the approved hours of operation will require separate Council approval.

### • 18 Restricted Consent Period

This consent is valid for a period of 24 months from the date of endorsement.
