SECTION A - REAL PROPERTY

For the purposes of this section "interest" includes an option to purchase.

SECTION B - SOURCES OF INCOME

Only provide information where the amount of income from that source exceeds \$500. Fees paid to the Lord Mayor and Councillors under the *Local Government Act 1993* **do not need** to be disclosed.

Examples of occupations could include: an employee of Council, an employee of other organisations, self-employment, consultant, an office holder in a company.

SECTION C - GIFTS
