## 4) BUSINESS ARISING FROM PREVIOUS MINUTES

#### a) KEIRA STREET PEDESTRIAN CROSSING FEEDBACK

Significant discussion occurred in relation to the need for some southbound cyclists to "bypass" the eastern kerb blister to avoid the squeeze point. The resulting action was for the Reference Group Chair to approach the Manager of Project Delivery for approval for Reference Group member(s) to liaise with design engineers on the project prior to construction

b) SMITH STREET ON ROAD CYCLEWAY FEEDBACK

Reference Group comments from previous meeting are being considered for design modifications. Design will be brought back to Reference Group for comment in the first half of 2015

#### SQUIRES WAY SHARED PATH

Correspondence from Phil Latz extended congratulations to Council (Lord Mayor & Councillors) for the excellent quality of the recently constructed shared path that runs along Squires Way, Fairy Meadow (copy of letter attached).

#### MOUNT KEIRA MOUNTAIN BIKE PARK

It was noted that an article was published on the Bicycling Australia website outlining a push by Wollongong Mountain Bike Club and Destination Wollongong, for an Adventure Playground including a mountain bike park at Mt Keira.

Phil Latz mentioned the article received the highest views ever, with 3700 views in 3 days, and stated that the main objective is to get the facility built.

#### DESIGN ISSUES WITH CONSTRUCTED CYCLEWAYS / SHARED PATHS

Werner Steyer brought discussion to the table about issues with newly constructed cycleways and shared paths and asked the question "how can we capture these issues for future learning?" Examples included a power pole in the middle of the newly constructed shared path on the Princes Highway at Kembla Grange, as well as a dangerous crossing at the "left in only" entrance to the KG Race Course.
