- 1 APOLOGIES Apologies were received and accepted on behalf of Jill Merrin and Mike Dowd
- 2 DECLARATIONS OF INTEREST Lachlan Anderson informed the group that he has joined a local surveying company that may in the future bid for work from Council.

5 GENERAL BUSINESS

ITEM 1 - DRAFT CORRIMAL TOWN CENTRE PLAN

Rebecca Jardim from the Land Use Planning team gave a presentation on the Draft Corrimal Town Centre Plan that is on public exhibition in August 2015. A summary on the development of the plan and its key recommendations noted the following:

- Community survey responses on active transport were relatively low compared to what is generally received in town centre studies
- Recommendations for Memorial Park play a core role in the strategy
- 500m walking catchment covers all town centre services however the walking environment is not pleasant
- ~2300 people crossing are crossing the princes highway in the town centre each day



- 30% of traffic on the highway was found to be through traffic (even subsequent to the construction of memorial drive)
- Flood prone areas significantly hinder the development opportunities in the town centre
- Numerous blank walls negatively impact the town centre
- The population of Corrimal could be amplified given the range of services available and level of public transport accessibility
- Key Actions include:
 - o Creation of a Town Square
 - Activation of edges around Memorial Park
 - Pedestrian friendly main street
 - o Renewed streetscape
 - o A new cycleway and footpath through Memorial Park
 - Footpath connection through Gilbert Street
 - New wayfinding signage
 - o Protect and enhance existing pedestrian connections
- The public exhibition period ends on 28 August 2015. A kiosk will be set up in the town centre on 15 August 2015

Stuart Porter suggested that the link from the scout hall to memorial park could be improved. The existing path condition in poor and is blocked at one location by a chain link fence.

Werner Steyer stated that the Plan should link in with the City of Wollongong Bike Plan and that the town centre should be connected to the coastline cycleway in a meaningful way

Phil Latz suggested that the plan should seek to make private vehicle travel less attractive than active modes.

Lachlan Anderson queried whether locating the major bus stop at memorial park would detract from the amenity of the park given impact of crowding and noise from buses.

ITEM 2 - SMITH STREET, KEMBLA STREET CYCLEWAY PROJECT CONSULTATION

Peter Nunn gave an overview of the Councillor Briefing on the Smith Street and Kembla Street project. A key issue discussed was the level of engagement to be employed in the communications strategy for the project.

Ann Martin suggested that information sent to community should detail why a particular side of the street was chosen for the facility. Furthermore, Council should link the proposed cycleway work with the wider parking strategy for the city centre to indicate how parking losses are offset in other parts of the city centre.

Stuart Porter suggested that the ad hoc parking area on the north side of Smith Street adjacent to the railway underpass could be formalised

Lachlan Anderson suggested that the introduction of car share (eg go get) as part of the project would help to reduce on street parking demand. Peter Nunn suggested that timing of car share introduction in Wollongong is likely to be subsequent to the cycleway project.

Lachlan Anderson recommended that a targeted form of consultation be employed for tenants and land holders that highlights the particular benefits and impacts relating to those groups.

Phil Latz suggested that the presentation of facts on positive impacts associated with bicycle infrastructure should be a central part of the communications strategy to help address emotion based arguments

Werner Steyer suggested that the various options considered should be presented to community as part of the engagement strategy

Phil Latz noted the need for permanent count stations to adequately capture usage data of the facility.

Ann Martin and Werner Steyer noted the need to involve the University of Wollongong in the project communications to increase use of the facility by the university population.
