ADDITIONAL INFORMATION

SECTION A - REAL PROPERTY

For the purposes of this section "interest" includes an option to purchase.

SECTION B - SOURCES OF INCOME

Only provide information where the amount of income from that source exceeds \$500. Fees paid to the Lord Mayor and Councillors under the *Local Government Act 1993* **do not need** to be disclosed.

Examples of occupations could include: an employee of Council, an employee of other organisations, self-employment, consultant, an office holder in a company.

The 'Settlor' is the name of a person who created the Trust

SECTION C - GIFTS

You do not need to include every gift you receive in your duties. You only need to include a description of a single gift or multiple gifts from the same donor, the total value of which exceeded \$500 in the reporting period.

Political donations disclosed, or required to be disclosed, under Part 3 of the *Electoral Funding Act 2018* do not need to be declared in this return.

SECTION E - INTERESTS AND POSITIONS IN CORPORATIONS

Declare only if your shareholding was greater than 10% of voting rights in the corporation. You must declare any position (not Shareholder) you held in a corporation (including not-for-profit corporations) such as Director, whether or not you held shares in the Corporation, or the position was a paid position.

Property Developer has the same meaning as in Division 7 of Part 3 of the *Electoral Funding Act 2018*. Close associate has the same meaning as in Section 53 of the *Electoral Funding Act 2018*.

SECTION H - DEBTS

- Debts related to goods or services you have purchased

SECTION I – DISPOSITIONS OF REAL PROPERTY
