7. REZONING APPLICATIONS - LAKE CATCHMENT AND FORESHORE

This is a standing agenda item and allows WCC and SCC to provide basic information on rezoning applications within the Lake Illawarra catchment for the Committee's information. David Green, Acting Manager Environmental Strategy and Planning WCC spoke to the WCC summary report. A SCC report was not submitted.

8 MAJOR CAPITAL WORKS - COUNCIL BASED - UPDATE

Martin Parmenter, Acting Manager Infrastructure Strategy and Planning WCC spoke to the Wollongong City Council section of the report.

Col Wilton sought clarification regarding council action on the Windang boat ramp. In a response received after the meeting it was clarified that the toe of the boat ramp is being extended as a part of the programmed construction works.

Courtney Williams Acting Group Manager Asset Strategy, SCC spoke to the Shellharbour City Council section of the Report.

John Davey raised concerns that the stormwater renewal works carried out at 251 Reddall Pde will result in erosion issues.

9. WEST DAPTO BIOCERTIFICATION PROCESS

Brett Morrisey, Environmental Strategy Officer, WCC spoke regarding the current biocertification process for West Dapto. The process is about making structural and functional improvements for flora and fauna and ensuring the biodiversity outcome is improved or maintained. Other considerations such as water quality and Aboriginal cultural heritage values are not explicitly taken into consideration in the process, but are managed in other ways.

The West Dapto site is about 70% through the biocertification process, but it is complicated due to the number of developers and size of the project.

Other WCC sites that have protection measures in place as a result of biocertification processes were discussed such as Puckeys and Redgum Ridge Estate.

10. SEDIMENTATION ENFORCEMENT POLICY UPDATE

Danny Madigan, Manager Regulation and Enforcement, WCC provided an update on the new sedimentation control requirements in the WCC Compliance and Enforcement Policy. The updated policy puts sedimentation pollution in the highest possible category of breach and will therefore be investigated within 24hrs of a compliant being made.

It is still very difficult to be proactive in reducing sedimentation pollution (eg compliance audits, site visits at implementation stage) without extra resources. The Draft CMP provides for these.

The need for Council staff to be more adequately trained in sedimentation issues has ben recognised and will be taking place soon. It is hoped that SCC staff (as well as Shoalhaven staff) will be able to be invited along to this training. Private Certifiers and their role in effective pollution control was also discussed.

The current management action in the CMP is good, but can be made better. Kristy is working with the EPA and will contact Danny about further changes.

11. CARDNO UPDATE RE TALLAWARRA LANDS

Daniel Thompson and David Laing from Cardno spoke to the following:

- An application for modification to the approved concept design for Tallawarra Lands is on public exhibition until 24 July. The three main modifications being sought are an increase in the residential development footprint, an increase in density and the uncoupling of the northern and central precincts to the southern precinct, which was the 'employment lands'. Concerns were raised regarding loss of recreational space, loss of land for other purposes, noise impacts from the proposed second power station to be built nearby, loss of visual amenity, reduced public access to recreational lands, Aboriginal cultural heritage losses.
- The overall vision for the development is one of activation on a national scale to get tourism and other opportunities to the area. The original vision documents have been removed from the web as they were overly ambitious and showed things that could not possibly happen (ie boats that could not possibly enter the lake, facilities that were impossible to provide as the lake is too shallow). Concerns were raised that the vision is not realistic and is dangerous given the current changing nature of the lake and its susceptibility to catchment development pollution.

The development has not been tested against the new NSW Government Coastal reforms package.

As far as the presenters are aware the lack of new exit from the highway will not stop the development. The developers are in negotiations with RMS and local members re this issue.

12. LAKE ILLLAWARRA OFFICER REPORT

Kristy Blackburn spoke to her report as outlined in the Business Paper. Further discussions were held regarding:

- Recent media attention had included Cr Cath Blakey, Annie Marlow and Col Wilton being interviewed re
 Tallawarra proposed development and also the delay to the CMP. The ABC published an article titled "A tale of
 two lakes' on 9 July comparing the progress of Lake Macquarie against the 'red tape' holding back progress for
 Lake Illawarra.
- The revised Vision for West Dapto will most likely be on public exhibition at the end of July. Kristy will forward this onto members when the consultation process begins.
- Works currently being carried out by contractors for Property NSW on King Street land are removing most of the vegetation on site. It is understood that a request was sent to Property NSW on behalf of the Lord Mayor asking that the site be tidied up and that this is the response. Kristy was informed by Property NSW that all environmental and other requirements are being met through Property NSW processes. Mike Dowd was sent information about the works but did not send this onto Kristy Blackburn for the Committee's information. Mike's apologies for the oversight were tabled by Martin Parmenter.
- The profile of the LIEMC should be lifted within the community and within the two Councils. A logo currently being developed will assist with this.
- The Committee agreed to submit a joint submission into the current application to modify the approved concept plan for Tallawarra Lands. Submissions have to be provided by 24 July so members will get comments to Kristy by 18 July to then be compiled and forwarded to the Committee for endorsement.

13 COMMITTEE MEMBER UPDATES (ROUND TABLE)

Cr Cath Blakey reported that she had recently walked the Tallawarra Ash ponds site again and had seen signs of deer and potentially wallabies. The Illawarra Birders are very concerned that the proposed Central Tallawarra development precinct will put the birds at the ash ponds under increased pressure.

Col Wilton asked for clarification re the works being undertaken at Skiway Park. These questions were subsequently answered by SCC after the meeting and included here for ease. Is the boardwalk being constructed as part of the first stage of works? No, Stage 1 is demolition, Stage 2 is construction. What was the outcome of the meeting held on site between SCC and the Illawarra Ramblers? Council will investigate the construction of a kayak-launching facility in conjunction with the reconstruction of the promenade; these investigations are ongoing.
