

#### **SECTION A - REAL PROPERTY**

For the purposes of this section "interest" includes an option to purchase.

#### SECTION B - SOURCES OF INCOME

Only provide information where the amount of income from that source exceeds \$500. Fees paid to the Lord Mayor and Councillors under the *Local Government Act 1993* do not need to be disclosed.
