2 FLOOD MANAGEMENT UPDATE

2.1 Collins Creek Floodplain Risk Management Study and Plan Review

The draft Flood Study was placed on Public Exhibition for the period 17 June to 19 July 2019 and adopted by Council on 23 September 2019.

Council is currently preparing a Technical Brief for the review of the Collins Creek Floodplain Risk Management Study and Plan. This project is funded by Council. The project seeks to identify the flood risks and damages to this catchment and assess and prioritise floodplain risk mitigation options.

2.2 Hewitts Creek Floodplain Risk Management Study and Plan Review

The draft Flood Study was placed on Public Exhibition for the period 9 September to 8 October 2019 and adopted by Council on 9 December 2019.

Council has started the review of the Hewitts Creek Floodplain Risk Management Study and Plan. This project is funded by the NSW Flood Program and Council. The project seeks to identify the flood risks and damages to this catchment and assess and prioritise floodplain risk mitigation options.

An update will be provided by Council's consultant.

2.3 Towradgi Creek Floodplain Risk Management Study and Plan Review

The draft Flood Study Addendum was placed on Public Exhibition for the period 9 September to 8 October 2019 and adopted by Council on 9 December 2019.

Council has started the review of the Towradgi Creek Floodplain Risk Management Study and Plan. This project is funded by the NSW Flood Program and Council. The project seeks to identify the flood risks and damages to this catchment and assess and prioritise floodplain risk mitigation options.

An update will be provided by Council's consultant.



2.4 Recent Floodplain Risk Management Plan Implementation

Council has been carrying out works to implement the currently adopted Floodplain Risk Management Plans. This include projects that have been recently completed, are underway, or are planned.

Collins Creek;

- Ursula Road Flood Mitigation Scheme, Bulli: Concept Design Draft Concept Design documentation has been prepared. Public consultation of the project is currently underway, with public exhibition of the draft documents occurring between 10 February - 10 March 2021. Public information sessions to be held 23 February (online) and 24 February 2021 (in-person session). An update will be provided by Council's consultant.
- Bellambi Gully Flood Mitigation Scheme The Concept Design has been finalised and public consultation carried out. The Detailed Design is now under way.
- West St Flood Mitigation Detailed Design has been completed. An update on this project will be provided at the meeting.
- Debris Control Structures Detailed design is well progressed at these sites. Gordon Hutton Park (Woonona), Memorial Drive (Bellambi), Russell Vale Golf Course (Russell Vale), Brompton Road (Bellambi). Further consultation will occur shortly.
