# 6.2 Windang Foreshore

Joanne Page provided an update on the status of Windang Foreshore

- Now called The Windang Foreshore Improvements
- WCC started proceedures regarding the Windang Playground on the Monday after the bad weather event. (refer attachment 2)
- The original emergency measures (rocks to reduce erosion) will not be effective.
- WCC will wait until the report is out towards the end of the year before taking action around the foreshore.
- WCC is aware of the prospect of ongoing erosion until the problem is resolved.
- Shellharbour Council provided the funding (via the State Govt) for their side of the lake
- Because of the erosion on WCC side of the lake it is necessary to have the study conducted prior to State Govt Funding
- It has also been included in the Recovery Program from the April 2024 Storm
- WCC will organise a community information session involving all involved parties

## " 6.3.2 Dob in a Hoon

 Joanne Page advised that the Traffic Committee is made up of NSW Police Force, TfNSW, the Local State Member of Parliament, and representatives of WCC. The Dob in a Hoon Program is part of the Committee and problem areas are reported on the Dob in a Hoon List and discussed at the Committee Meeting and a multi-agency approach can be taken. Joanne Page advised that the "Dob in a Hoon" can be anything from – going too fast, through a stop sign, burn outs etc. To lodge a complaint about any "bad" traffic behaviour you can lodge a request through Customer Service or online service request. Please ask for the matter to be referred to Traffic Committee as a "Dob in a Hoon"

Action – NF7 members to individually lodge a request with WCC every time they have an incident.

Action – Peter Maywald to continue to lobby about traffic related incidents."

- Mimosa license has been reinstated. But the license is in abeyance until a DA is submitted for what they are actually going to do on the land

- 6.7 Responsible Cat Ownership
  - RSPCA is no longer accepting stray animals. Cr Martin advised that the WCC will take the animal to Illawarra Animal Hospital where it is checked for microchip and kept for 24-48 hr and then sent to one of the rehome organisations including RSPCA Kemps Creek
    - Action Continue to monitor

6.8 Camping at Merinda Jetty Car Park/ Kully Bay

- It was noted that there are more and more vehicles setting up camp in the Merinda Car Park. The land is not WCC land and so therefore needs to be addressed with Paul Scully MP to stop before it gets to be like Kully Bay. Residents are concerned about many aspects including health, intimidation and safety.
- It was also noted by numerous forum members that they had experienced people exiting/ entering bushes with toilet paper in hand.
