4 BUSINESS ARISING FROM PREVIOUS MINUTES

- 5 WONGAWILLI MINE REOPENING IMPLICATIONS
  - Wongawilli Mine has been in care and maintenance mode since mid-2019, with Wollongong Resources focussing its energy on Russell Vale Colliery.
  - Discussed potential transport noise issues when mine reopens. The West Dapto DCP chapter includes a noise buffer area around the rail line which require new houses to have noise attenuation measures. Additionally, there is a property notation which would appear on each Planning Certificates advising of the buffer area. Council staff expect the private rail line would be used to transport coal from the mine if the mine reopens.

# 6 DRAFT SOCIAL INFRASTRUCTURE NEEDS ASSESSMENT

- Council has been planning for social infrastructure needs for West Dapto for many years. Social infrastructure is described as the places and spaces in a community that help people connect, be active, create and learn.
- Council coordinated a Needs Assessment to review what the growing community in West Dapto will need in the future and invited the community to view the Assessment and provide feedback by 28 February 2023.
- Common themes received from the community school site planning, connectivity, open space, community facilities and multi-use facilities locations and shared pathway networks.



MINUTES West Dapto Review Committee

- Council's Engagement Team and Urban Release Team have engaged with Neighbourhood Forum 8, schools

   via a local Principals group, Aboriginal community, Koori Men's Group, sporting facilities and community
   groups.
- Council is currently considering submissions and will provide feedback to Councillors prior to a final recommendation report going to Council.

# 7 MULLET CREEK FLOODPLAIN RISK MANAGEMENT STUDY AND PLAN

- Collaborative work is currently being done by the Council team and proponents.
- General agreement to use the 2023 flood model as part of work on the Cleveland Planning Proposal.
- A series of meetings is being held so the technical experts from the owners' group and Council can be clear about the process to finalise the Cleveland Planning Proposal. There will be clarity around the process and expectations for all parties prior to additional owners' group modelling being made available.
- Once the model is completed (expected in the next few weeks), Council staff will provide to the developers to start to use. This will include a caveat that the model is subject to Council adoption and to be used by the developer group at their own risk.
- The Southern Floodplain Risk Management Committee has endorsed the Floodplain Risk Management Study and Plan being reported to Council.
- The 2023 flood model approach incorporates climate change factors. Currently developers are asked to look at climate changes factors separately. The 2023 flood approach will be an improved approach once finalised.

# 8 INCREASED RISK RATING OF KEMBLA GRANGE LEVEL CROSSING

- The NSW Department of Planning and Environment has supported Council and Council's project partner Transport for NSW, by providing grant funding under the State VPA Program – Northcliffe Drive Extension Strategic Business Case Project.
- Council lodged its formal strategic business case in February 2023.
- At the time of finalising the strategic business case there was an emerging issue relevant to the Northcliffe Drive Extension. The strategic business case incorporates reference to recent correspondence received from Transport for NSW (Sydney Trains). Concern has been raised with the significant number of vehicles, including trucks, that would be using the Kembla Grange level crossing because of a current proposed development application in West Dapto. Sydney Trains has noted that the proposed development would result in the Australian Level Crossing Assessment Model (ALCAM) rating of the level crossing rising to a higher risk level, and as a result, the agency is not yet in a position to provide concurrence to the development application. This will have implications for the current development application and ongoing development assessment processes at West Dapto until grade separation is achieved via the Northcliffe Drive Extension. Council staff will work with Sydney Trains to seek management solutions for the short-term issue. However, the Northcliffe Drive extension is the ultimate solution.

# 9 BIOCERTIFICATION

- Final Biocertification Application was lodged with the Department during February 2023 seeking support for public exhibition.
- The Department subsequently made a request for additional information. Council staff are currently working on additional supporting information for exhibition. Target for exhibition is April 2023.

#### 10 WEST DAPTO SUBURBS REVIEW

• On 8 August 2022, Council resolved to lodge a submission to the Geographical Names Board (GNB) responding to issues raised during their GNB public exhibition of the proposed new Suburbs 'A' and 'B' under the West Dapto Suburbs Review.

- The submissions for Stream Hill were considered by the Geographical Names Board at its meeting on 13 September 2022 and recommended the proposed name and modified boundaries to the Minister for approval. Gazettal will not take place until after the NSW State Election in March 2023.
- Review of the two other suburbs Huntley and Avondale are in abeyance as per Council resolution.

## Draft Social Infrastructure Needs Assessment

#### West Dapto Centres Master Planning Project

- The NSW Department of Planning & Environment has agreed to fund the West Dapto Centres Master Planning
  Project via the Regional Housing Strategic Planning Fund, which will support Council in planning for housing
  supply to meet local community needs.
- The Fund addresses the need for improved upfront strategic planning, including investment in technical studies to resolve barriers to new housing earlier in the planning process. This will ensure subsequent planning assessments and processes can be streamlined and rezoned land is practical and feasible to develop.
- URBIS has been engaged to carry out urban design work and engagement with landowners as part of this work.
- There was a general discussion by the Committee members regarding Town Centre and Neighbourhood shopping centre footprints, walkability and driving to centres.

#### West Dapto Green Network Master Plan

- The draft Plan is currently with staff for internal comment prior to being revised for reporting to Council.
- A report on the draft Green Network Master Plan is anticipated to be presented to Council mid-year. This could potentially come to Councillors for consideration as a package along with the West Dapto section 7.11 draft contributions plan 2023.

#### 12 WEST DAPTO ACCESS STRATEGY

#### Upgrade of West Dapto Road

- Council has been in constant contact with community members throughout the upgrade of West Dapto Road to deliver infrastructure which will ensure community safety and improved access for this growing area now and into the future.
- Line marking will be taking place on 15-16 March 2023 working outside of peak hours at night, so to minimise impacts to local residents.
- Approximately 36 projects have been finalised in the West Dapto area.
